## **Component Description**

The Initial IEP Component may only be reported once for any single episode of special education services and/or programs. An episode begins when a student not currently receiving special education services or programs is referred for a special education evaluation. The episode ends when the student has been exited from special education services. An exit is determined by IEP and/or graduation or completion of K-12 education.

An error occurs when a subsequent InitialIEP component is submitted for a student who has not been exited from a previous special ed episode.
